This year, applicants can apply for specific training to address mental health and wellness, life promotion, and suicide prevention for their organizations.

## Funding

**ESDC Enabling Accessibility Fund - Small Projects:** This funding opportunity aims to make communities and workplaces across Canada more accessible for persons with disabilities. It will fund projects up to \$125,000 that create more opportunities for persons with disabilities to take part in community activities, programs and services, and access employment. Deadline is July 23, 2024.

**Grants to Youth Serving Organizations:** Provides special project funding of up to \$30,000 for not-for-profit youth-serving organizations operating in Newfoundland and Labrador. The goal of Grants to Youth Organizations is to help youth-serving organizations create opportunities for inspiration, mentorship, and social inclusion for youth in Newfoundland and Labrador. Deadline is June 21, 2024.

**Dollar a Day Foundation:** The Dollar A Day Foundation has a simple mission: to provide adequate funding to frontline mental health and addictions programs across Canada. Although the Dollar A Day Foundation works primarily through its partners to identify programs in need of funding, if your organization delivers frontline programs in support of persons with mental health and addictions, we encourage you to submit a two-page summary of your project to [info@dollaraday.ca](mailto:info@dollaraday.ca)

**Rona Foundation's Build from the Heart:** this campaign is to provide financial support to

non-profits that have a project aimed at revitalizing a living environment or facilitating access to housing for victims of domestic violence and their children, low-income families and people with disabilities or mental health issues. A total of \$1,000,000 will be awarded to seven nonprofit organizations to support their projects. Charities wishing to submit their project to benefit from the program can apply from May 1 to June 14, 2024:

**[Canadian Dermatology Association Share Structure Grant](#)**: The program provides funding to schools, daycares, city parks and not-for-profit organizations to purchase or construct permanent shade structures in order to create a safe outdoor environment that protects people from the sun's harmful ultraviolet radiation. Five grant recipients may receive up to \$7,500 each to go toward the cost of materials and installation. The deadline for submissions is Friday, June 28, 2024, 11:59 p.m. (ET):
