

Community Sector Council NL Announces Social Acquisition Through the SETA Program; Two Whales Coffee Shop Acquired By Table 8 Co-operative

Port Rexton, July 22, 2025 - The Community Sector Council of Newfoundland and Labrador (CSCNL) is excited to celebrate the acquisition of the Two Whales Coffee Shop by Table 8, a worker-owned Co-operative.

Two Whales is an important community hub and tourism business in Port Rexton that serves organic, garden-grown vegetarian fare, coffee, and baked confections. After 16 years in business, founders David Ellis and Sue Asquith have retired and secured an agreement with a group of existing employees. Olivia White, Jill White, Carrie Hookey, Penny Vivian-Penney, and Rebecca Hiscock formed Table 8 Co-operative and began operating Two Whales Coffee Shop in May.

SETA provides funding and support for community organizations to acquire businesses. This transformative initiative uses hands-on capacity building, matching, and connection to financing to enhance community well-being by preventing the closure of rural small businesses. SETA is made possible with funding from the Northpine Foundation, the Government of Newfoundland and Labrador, and the Atlantic Canada Opportunities Agency (ACOA). This acquisition was made possible with support from our project partners, the Newfoundland and Labrador Federation of Co-operatives (NLFC).
